



2021 International Female Ride Day® Photo Share Giveaway Sweepstakes Terms and Conditions

Eligibility: Just enter to win! Submit your International Female Ride Day® (IFRD) photo via the IFRD online entry form and your name could be drawn to win! Entrants must be 18 years of age as of their date of entry to qualify; no purchase necessary. Only one image per person will be entered.

IFRD Photo Share Giveaway winners will be selected by random via draw under witness supervision. The name provided with photo submission is the entrant submitted to the draw. Images submitted must have been taken on IFRD, 1 May 2021.
